

## **LECTROSONICS, INC.**

### **"Sound of the Fanatics" Contest Official Rules**

Concept: participants can download our animated logo file (video) and submit an entry with their own sound interpretation added.

One entry will be chosen as "winner", and this version will be used for the intro to all Lectrosonics video tutorials and other video material (on YouTube channel) for at least 1 year. Person submitting winning entry will receive one (1) SSM (US or E01, E02, E06, depending on the winner's home region) transmitter in the frequency band of their choice (A1, B1 or C1) at no cost, shipped worldwide.

Rules:

No purchase necessary to enter or win. A purchase will not increase your chances of winning. All federal, state, local, and municipal laws and regulations apply. Void where prohibited.

#### **1. Eligibility**

The contest is open to any participants worldwide who are at least eighteen (18) years old at the time of entry. Employees of Lectrosonics and other companies associated with the promotion of the contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

#### **2. Sponsor**

The Contest is sponsored by Lectrosonics, Inc., located at 581 Laser Rd. NE, Rio Rancho, NM 87124, USA.

#### **3. Agreement to Official Rules**

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

#### **4. Contest Period**

The Contest begins on June 7th at 8:00 AM (Mountain Daylight Time) and ends on June 30th at 5:00 PM (MDT) (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified.

#### **5. How to Enter**

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, email address, or household in excess of the stated limitation will be void. All entries become the property of Lectrosonics and will not be acknowledged or returned. Submit entries using the Entry Form on the web site.

## 6. Prize Selection

Beginning on July 6 but no later than July 29, Lectrosonics will select a single "best" winner after viewing and listening to all entries. Lectrosonics will attempt to notify the potential winner via telephone or email on or about August 1. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, Lectrosonics may select an alternate potential winner in his/her place from the remaining non-winning, eligible entries.

## 7. Winner Notification

The potential winners will be notified by email or phone. Each potential winner (parent/legal guardian if a minor in his/her state or country of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date of notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Lectrosonics reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winner's behalf and fulfill any other requirements imposed on winner set forth herein. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner from among all remaining eligible entries. Prizes will be fulfilled approximately 4-6 weeks after the conclusion of the Contest.

## 8. Prize

Winning entry for the "Sound of the Fanatics" Contest to receive an SSM (or E01, E02, E06) micro bodypack transmitter in the frequency band of their choice (A1, B1 or C1), shipped worldwide. This SSM transmitter will include the standard accessories as shipped in the region where the winner resides.

## 9. General Conditions

In the event that the operation, security, or administration of the Contest is impaired in any way for any reasons, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem or in the event the Contest is unable to run as planned for any other reason, as determined by Lectrosonics in its sole discretion, Lectrosonics may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules, or (b) terminate the Contest and, in the event of termination, award the prize from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be active in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Lectrosonics reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by Lectrosonics to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

## 10. Release and Limitations of Liability

By participating in the Contest, entrants agree to release and hold harmless Lectrosonics, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies

associate with the Contest, and each of the respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including but not limited to (a) any technical errors associated with the Contest, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures, or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) any other errors or problems in connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation or postponement of the event, or in any Contest-related materials; or (e) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties liability will be limited to the cost of entering and participating in the Contest, and in no event shall the entrant be entitled to receive attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New Mexico, USA. All issues and questions concerning the conditions, validity, interpretation and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of Lectrosonics in connection with the Contest, shall be governed by, and construed in accordance with, the laws of New Mexico, USA, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than New Mexico, USA.
